6. Provision of platform for the establishment of Environmental Clubs with the name "Climate Action Group"<sup>[?]</sup> in selected primary and secondary schools in Nigeria, with a view to catching the children young and instill environment concern into the psyche.
7. Organization of environmental waste recycling youth empowerment programme in Bauchi State, Nigeria, for 120 members tagged #ClimateAction and #CAGBauchi in 2019-2020.
