SAID PDT MACRON AHEAD OF NATO SUMMIT

You have often heard me defend this concept in which I believe deeply, that of a European Union which needs to build the framework of its strategic autonomy in economic, industrial, technological and military matters. We have a solid record in this regard in recent years: a Europe of defense has progressed as it had not progressed since the 1950s, strengthened cooperation, a European Defense Fund, joint projects, in particular Franco-German, that we have extended to a few other partners who have made massive progress in recent weeks. We have succeeded in chairing a revival in terms of technological sovereignty over 5G, but also over essential components, with a Commission that is much more focused on this agenda and in particular in terms of digital technology, the DMA / directives. DSA and we built economic and financial sovereignty during the unprecedented crisis, in particular thanks to the German-French initiative of May 2020 and then to the July summit which made it possible to build a common debt capacity and an investment plan unpublished. Responsibility when it comes to managing our neighborhoods, the Balkans, the Mediterranean, the African continent. As such, 3 things are essential to me for the upcoming NATO summit. The first is that precisely these consolidation efforts are respected in the dialogue and that the strategic capacity autonomy of the Europeans be recognized.
